The proposed ordinance presents a text change to the Camden County Unified Development Ordinance. The language change is necessary for the addition of Recreation Entertainment Indoor and Outdoor Principal Use Category and event venue type.

The Text amendment will amend the Camden County Code of Ordinances Chapter 151 for the following Articles:

- Article 4 Use Regulations:
 - 4.3.10 Principal Use Table
 - 4.4.4 Commercial Uses
 - Table 4.5.4
 - 4.5.5 Standards for Specific Accessory Uses
- Article 10 Definitions & Measurements:
 - Table 10.3 Definitions

The Planning Board voted unanimously to recommend approval with revisions and Planning Staff supports the recommendation.

Planning Director Amber Curling presented the following proposed Ordinance 2025-07-01 and Specific Event Permit Application.

An Ordinance
Amending the Camden County Code of Ordinances
Camden County, North Carolina

BE IT ORDAINED BY THE CAMDEN COUNTY BOARD OF COMMISSIONERS as follows:

Article I: Purpose

The purpose of this Ordinance is to amend Chapter 151 of the Camden County Code of Ordinances of Camden County, North Carolina, which was originally adopted by the County Commissioners on January 1, 1998, and subsequently revised February 4, 2019 and subsequently amended, and as otherwise incorporated into the Camden County Code.

Article II: Construction

For purposes of this Ordinance, underlined words (underline) shall be considered as additions to existing Ordinance language and strikethrough words (strikethrough) shall be considered deletions to existing language. New language of proposed ordinance shall be shown in *italics* and highlighted (bates).

Recreation/Entertainment Indoor and Outdoor

Example use type is an Event Venue for Private Celebratory Gatherings (Wedding, Birthday Party, Retirement Party, Anniversary, and the like) and Other Private Approved Events.
Event Venue
A physical place inside and/or outside where an event or special occasion can be held. These venues can be large or small.

Article 151.4.4. COMMERCIAL USES Unless exempted, all commercial uses shall comply with the nonresidential design standards in Section 5.1.2, Commercial Design Standards, or Section 5.1.3, Mixed-Use Design Standards, as applicable.

F. Recreation/Entertainment, Outdoor

Outdoor recreation and entertainment uses shall comply with the following standards.

1. General Requirements Applied to All Recreation/Outdoor Use Types

All recreation/outdoor use types shall:

- Be located at least 500 feet from existing child care centers and residential zoning districts;
- Be located on a site or parcel with an area of at least five acres;
- Be located on a site or parcel that, at the primary point of access, has at least 200 feet of frontage on a collector street;
- Locate access points to minimize traffic to and through local streets in residential neighborhoods;
- Provide safety fences, up to eight feet high, as necessary to protect the general health, safety, and welfare.

M. Event Venue – The following limitations are based on the health, safety and welfare of the public:

- The Purpose and Intent of the Special Use Permit is to regulate new development of an event venue as principle or accessory use for a parcel.
- Be located at least 500 feet from existing child care centers, use type and 500 feet from prohibited residential zoning districts.
- Be located on a site or parcel with an area of at least five acres.
- The Special Use Permits will be updated/re-evaluated/reviewed annually to determine compliance with this Ordinance. The applicant must strictly abide by all requirement of the current Unified Development Ordinance of Camden County, North Carolina, and must strictly comply with all other local, state, and federal ordinances, laws, rules and regulations as one or more ordinances, laws, rules regulations may apply to this special use permit.
- Each event will require Event Application documentation of actions taken for the specific event.
- Determine Occupancy limitation to be based on all relevant factors including, but not limited to, size of parcel, maximum occupancy load of building, parking limitations, type of event, access, etc.
- Parking Plan for specific event.
- Requirement of each Event Specific Safety Plan must be in place. These safety measures will be customized for each event and determined by the event's specific characteristics. For example, security personnel, traffic control personnel, fire escape, etc.
- Limitations on the time and dates for each event determined by Camden County and/or Emergency Management staff.
- A minimum requirement 50 feet setbacks of all recreation/entertainment features to include but not limited to stages, tents, bounce house, food/beverage trucks, tables/chairs/seating, petting zoo, vehicles (not in parking lot), etc. for event from property lines. The minimum setback for specific features will increase if determined necessary.
- Limitation on the specific types of events determined by Camden County.
- Details about maximum occupant load for building(s) determined by Fire Marshal.
- The name, address, contact number of the person (s) responsible for operation of each specific event.
- Details of catering provided for each event.
- Specific Details for each event as applicable:
 - Sanitation facilities
 - Noise control measures
 - Crowd control
 - Traffic control plan
 - Parking plan
 - Relevant information to minimize adjacent property owners being affected
 - Other actions taken to eliminate adverse effects
- A site plan of event layout. To include but not limited to parking, entrance/exit vehicle aisles, pick up/drop off areas, location of booths/catering vehicles, tables, tents, etc.
- Provide safety fences, up to eight feet high, as necessary to protect the general health, safety, and welfare of public.
- Fire Marshal/Sheriff approval when applicable.
- If alcohol is present or being served a valid ABC license required.
- Obtain and remain in compliance with any specific Permits and/or licenses required for all events.
- If any of the conditions affixed hereto or any part thereof shall be held invalid or void, then the approval in its entirety shall be void and have no effect.

The next section Unified Development Ordinance Article 151.4.5 Accessory Uses is adding a Text Amendment to include Recreation/Entertainment Indoor/Outdoor as an Accessory Use to a Principal Use. Article 151.4.5.1 states "This section of the Unified Development Ordinance authorizes the establishment of accessory uses and structures that are incidental and subordinate to principal uses. The purpose of this section is to allow a broad range of accessory uses and structures, provided they comply with the standards set forth in this section in order to reduce

potentially adverse impacts on surrounding lands." See below for Text Amendment of Event Venue as an Accessory Use to the Principal Use listed in Table 4.3.10.

ARTICLE 151.4 Use Regulations

Section 4.5 Accessory Uses

4.5.1 Purpose

4.5. ACCESSORY USES

4.5.1. PURPOSE

This section authorizes the establishment of accessory uses and structures that are incidental and subordinate to principal uses. The purpose of this section is to allow a broad range of accessory uses and structures, provided they comply with the standards set forth in this section in order to reduce potentially adverse impacts on surrounding lands.

4.5.2. PROCEDURES FOR ESTABLISHMENT

A. Accessory uses or structures may be approved in conjunction with the approval of the principal use or subsequently following the establishment of the principal use.

B. With the following exceptions, no accessory use or structure shall be approved, established, or constructed before the principal use is approved in accordance with this Ordinance:

- Agricultural uses.
- Docks, piers, and boat ramps; and
- Storage and maintenance sheds of up to 200 square feet in area.

C. Establishment of an accessory use or structure shall require approval of a zoning compliance permit in accordance with the standards in Section 4.3.29, Zoning Compliance Permits, and the standards in this section.

D. A lawfully-established nonconforming use or structure may be supplemented with an accessory use or structure provided the accessory does not increase the nonconformity.

4.5.3. GENERAL STANDARDS FOR ACCESSORY STRUCTURES

A. Permitted Accessory Uses and Structures

Permitted accessory uses and structures include those listed in this section and those that the UDO Administrator determines meet the following:

- Are clearly incidental to an allowed principal use or structure;
- Are subordinate to and serving an allowed principal use or structure; and
- Contribute to the comfort, convenience, or needs of occupants, business or industry associated with the principal use or structure.

4.5.4. TABLE OF ALLOWABLE LOCATIONS

A. Table as Guide

Table 4.5.4, Common Accessory Use Table, is established as a guide to identify the appropriateness of the more common accessory uses in each zoning district.

B. Listed Accessory Uses

Table 4.5.4, Common Accessory Use Table, lists what types of accessory uses, structures, and activities are allowed in each of the zoning districts.

- If a specific accessory use is allowed by-right, the cell underneath the zoning district is marked with a "P".
- If a specific accessory use is allowed subject to a special use permit, the cell underneath the zoning district is marked with a "S".
- If the accessory use or structure is not allowed in a zoning district, the cell is blank "-".
- In the case of planned development districts, if an accessory use is allowable, it is marked with an "A", and the accessory use must be set out in the approved master plan or terms and condition statement.
- If there is a reference contained in the column entitled "Acc. Use-Specific Standard," see Section 4.5.5, Standards for Specific Accessory Uses, for the additional standards that apply to the specific accessory use.

Event Venue

The specific parcel of land where a business or organization, profit or not profit, hosts indoor and outdoor private events. The private event is an exclusive gathering not open to the general public with the ability to accommodate specific event needs and various types of events. Any business, profit or non-profit, organization established on or after January 1, 2022 will require a Camden County Zoning Compliance Permit and be recognized by Camden County Tax Department. Any business, profit or non-profit, organization established prior to January 1, 2022 recognized by Camden County Tax Department will be legally non-conforming.

Discussion

Commissioner Krainiak stated he did not feel prepared to make a decision at that time. Mrs. Curling offered to answer any questions to address his concerns.

Chair White suggested that numbers 2 and 3 under Section M. Event Venue be removed. Commissioner Banks concurred and also asked Mrs. Curling to clarify that the specific language was added by the Planning Board. Mrs. Curling explained that the language was added by the Planning Board.

There was additional discussion in regard to specific acreage and properties surrounding the Camden Fields event venue.

Commissioner Banks inquired as to any complaints specifically in regard to Camden Fields in that no one had signed up for public comment. Mrs. Curling noted that there had been a noise complaint from a neighboring property owner.

Public Comments

- Vickie Stafford of South Mills inquired as to a definition of Working Lands. Mrs. Curling explained that it is a zoning district, normally five acres or more and located outside of the Core Village and the one-mile buffer; usually larger parcels. Mrs. Stafford also inquired as to the use type that this ordinance will affect, specifically in regard to churches. Mrs. Curling explained that this ordinance is not specifically addressing established churches, unless a church wants to build a separate large event venue as an accessory and plans to hold events that are beyond normal church uses such as weddings or funerals.
- Doug Mentzer with Camden Fields event venue addressed the Board and included the following in his comments:

- Held two neighborhood meetings to address concerns; contracts state that noise must end at 10 PM.
- Acknowledged that he had received a call in regard to a noise complaint at 10:15 PM during an but measures have been implemented to prevent a reoccurrence.
- Considered possible use of decibel meter to measure noise levels.
- Inquired in regard to a fence requirement that was discussed.

Mrs. Curling clarified the types of use where fencing may be required for safety purposes; not noise buffering and would not apply to event venues.

Commissioner Banks suggested adding to the Special Use Permit a requirement for the venue to maintain decibel meters with logging capabilities for a specified period of time.

Manager Burke stated that can be a site-specific requirement and doesn’t necessarily need to be included in the text amendment.

A lengthy discussion ensued in regard to noise control measures and devices used to measure noise such as a decibel meter. This discussion included comments from Sheriff Jones in regard to legal implications of using such devices without the proper training as well as citizen David Chick who has professional knowledge of noise-monitoring devices. Both Sheriff Jones and Mr. Chick referenced the required maintenance of the devices in addition to training and the effect of the device placement on the measured results.

Upon inquiry by Chair White in regard to the stated 500-foot distance requirement, Mrs. Curling explained that it refers to 500 feet *outside* the property line.

Commissioner Leary inquired of Sheriff Jones as to the enforcement of noise without a meter. Sheriff Jones stated that it is not enforceable; and again, such enforcement would require the purchase of the meter, providing training for its use as well as required maintenance.

Motion to approve Ordinance 2025-07-01 Text Amendment to the language of the Camden County Code of Ordinances Chapter 151, specifically to sections of Articles 154.4 Use Regulations and Article 151.10.3 Definitions to include Recreation Entertainment Indoor and Outdoor Principal Use Category and Event Venue Use Type, with the amendment of Section M, Numbers 2 & 3 to be excluded.

We are pleased to offer the following *scope & fee proposal* to continue to provide services for Camden County's wastewater future, particularly for the South Mills service area.

Under this Agreement, Timmons Group, in conjunction with Environmental Consulting & Technology, Inc. (ECT), will perform the Summer Field Sampling Program on the Pasquotank River and a subsequent Water Modeling Report for submission to the North Carolina Department of Environmental Quality (NCDEQ). This is a necessary step to develop a surface water discharge model and ultimately towards applying for and obtaining a National Pollutant Discharge Elimination System (NPDES) Permit for a surface water discharge on the Pasquotank River.

Additionally, Timmons Group, in conjunction with Soil & Environmental Consultants, Inc. (S&EC), will perform additional field work and analysis to pursue land application of treated effluent as an alternative or supplement to surface water discharge.

PROJECT BACKGROUND, UNDERSTANDING AND APPROACH
The South Mills Wastewater Treatment Plant (WWTP) located in Camden County, NC has a design capacity of 100,000 gallons per day (GPD) and land applies treated effluent via spray irrigation. Wastewater flows are currently well below design capacity. However, two major residential/commercial developments are planned within the South Mills WWTP service area that will add more than 2,000 homes and thousands of square feet of commercial space. 20-year buildout demand is expected to be approximately 1.0 million gallons per day (MGD).

Project Work Completed and In Progress

South Mills WWTP PER & Design: Timmons Group Project Number 46974 & 49767
In March 2021, Timmons Group prepared a technical Preliminary Engineering Report (PER) to better inform future decision making regarding South Mills WWTP. Following a change in leadership at the County, a PER Addendum was issued in January 2022. Based on the PER recommendations, design of a new 250,000 GPD WWTP (expandable to 1.0 MGD) occurred in 2022. As grant funding ended in

Camden County Wastewater – Modeling Phase 2B

Scope & Fee Proposal

September 2022, the new WWTP design documents were halted at the 60% design stage, with the intention of completing design in the near future.

Surface Water Discharge PER: Timmons Group Project Number 49767
The planned expansion of the WWTP necessitates increased capacity for effluent disposal. Timmons Group prepared the July 2022 Surface Water Discharge (SWD) PER to evaluate permitting a surface water discharge on the Pasquotank River. The PER focused on three major topics: (1) the permitting process and requirements with NCDEQ, (2) how the speculative effluent limits may affect the WWTP design, (3) potential outfall locations and effluent pipeline alignment alternatives.

Camden WWTP Planning: Timmons Group Project Number 67697
A new wastewater system in the northern end of the County is required to support proposed development. There are multiple due diligence items the County is evaluating in order to confirm the viability of this project. Securing a new NPDES Permit and constructing a new WWTP and effluent conveyance system is a major undertaking.

To help the County understand the breadth of what is required, Timmons Group prepared a holistic, overall PER for the project, a preliminary rate study to understand the financial viability of the project, and prepared a PowerPoint presentation to present to the Board of Commissioners. Additionally, Timmons Group is preparing grant applications in an effort to secure additional funding for the project.

Timmons Group presented the draft PER, draft preliminary rate study, and draft Board presentation to Public Works Manager Chuck Jones on October 28, 2024. Timmons Group presented the findings of the Wastewater Planning Study to the Board in April 2025.

Camden Stream Model Development Phase 1: Timmons Group Project Number 70349
Camden County and Timmons Group had a preliminary discussion with NCDEQ on June 19, 2024, to discuss permitting requirements. This discussion indicated that the most feasible location for a surface water discharge into the Pasquotank is in the Burr Mill area. NCDEQ indicated that the next step would be to prepare an in-stream sampling and modeling plan for NCDEQ review.

Monitoring and modeling will be complex. Primary challenges include tidal conditions, discharging into swamp waters, and downstream total maximum daily loads (TMDLs). Potential discharge locations will need to be evaluated at a variety of flow conditions, including low flow. To continue the permitting process, modeling must indicate that algal activity in lower portions of the Pasquotank River will not be affected and that the DO deficit would be less than 0.1 mg/L.

Timmons Group partnered with Environmental Consulting & Technology, Inc. (ECT) to perform the surface water discharge modeling. ECT has extensive experience in planning and preparing discharge models for regulatory approval. To determine the scope of modeling required, ECT performed reconnaissance on the Pasquotank River and water quality monitoring to establish basic background water quality and flows. This step has helped scope the full surface water discharge model and determine the level of modeling required. The draft Model Study Plan was provided to DEQ subsequent to the January 6, 2025 call with DEQ.

On January 24, 2025 DEQ indicated the following: "Our team met to discuss the project today, and we will be getting the comments back on the model plan soon. The modeling group confirmed that the winter field sampling requirements are adequate, and the winter sampling can be conducted."

Therefore, based on DEQ comments, the next phase of the stream model study moved forward.

It is established to provide oversight and support for all active adult programming directly supported by Camden County for residents that are at least 55 years of age. ARTICLE II <u>Purpose & Objectives</u> The Camden County Center for Active Adults Advisory Board shall be responsible for the following duties: 1. Serve as the liaison between the citizens of the county that are at least 55 years of age and the County of Camden. 2. Suggest policy and make recommendations to the Camden County Board of Commissioners (BOC) on special needs registry of the elderly. 3. Work to stimulate and promote needed services and programs for older citizens. 4. Review and make recommendations concerning service proposals and funding of services that have an impact on older citizens. 5. Review the proposed annual budget with the Senior Center Coordinator and the Recreation Director prior to the budget being submitted to the County Manager. 6. Perform other functions and duties as may from time to time be requested by the County Manager and the BOC.	ARTICLE III <u>Membership</u> 1. The Camden County Center for Active Adults Advisory Board shall be composed of up to seven (7) members who are residents of Camden County to include the Director of Social Services (or a designee) and a County Commissioner. The Camden County Center for Active Adults Advisory Board shall include at least three (3) members who are 55 years of age preferably one representing each district (Courthouse, Shiloh, South Mills) of the county, excluding the Director of Social Services (or a designee) and the County Commissioner. 2. Camden County Center for Active Adults Advisory Board appointees shall serve for a three (3) year term. Members may not serve for more than three (3) consecutive three (3) year terms. 3. All vacancies in the Camden County Center for Active Adults Advisory Board shall be filled by appointment by the BOC within 60 days and the person appointed shall begin a new three (3) year term. 4. Any member of the Camden County Center for Active Adults Advisory Board who misses more than three (3) meetings in any twelve-month period shall lose their status as a member of the advisory board and shall be replaced by the BOC. Absences due to sickness, death in the family or an emergency shall be considered approved absences and shall not affect the member's status. 5. The roster of the Camden County Center for Active Adults Advisory Board members shall always be available to the public and published on the county website. 6. Officers may be elected to succeed themselves but may not exceed two (2) consecutive terms in any position. ARTICLE IV <u>Meetings</u> 1. Regular Meetings of the Camden County Center for Active Adults Advisory Board shall be held quarterly or as otherwise needed. 2. Most of the advisory board shall constitute a quorum for the transaction of business for any meeting of the Camden County Center for Active Adults Advisory Board. 3. The meetings shall be subject to the open meetings law and advertised to encourage public attendance.

CONTRACT FOR ANIMAL CARE AND SHELTER SERVICES CAMDEN COUNTY, NORTH CAROLINA THIS CONTRACT is entered into this _____ day of _____, 2025 by and between the SPCA of Northeastern North Carolina, Incorporated, located at 102 Enterprise Drive, Elizabeth City, NC 27909, Pasquotank County, hereinafter referred to as the “CONTRACTOR” and the County of Camden, hereinafter referred to as the “COUNTY”, the parties hereto. DEFINITIONS “STRAY OR LOST ANIMALS”. Camden County Animal Control and Protection Ordinance Chapter 93 Any stray animal impounded is dealt with as provided in Chapter 93, Article 5 of the Camden County Animal Ordinance. “Stray or Lost” means any animal found within the county wandering at large which does not have an owner and does not bear evidence of identification of any owner, or any animal whose owner, if determinable, has failed to attach a valid rabies tag or identification tag for the animal pursuant to Camden County Animal Ordinance Chapter 93, Article 1 §1. § 130A-184. Definitions NCGS Public Health 4(a) Feral-An animal that is not socialized. 6(a) Stray-An animal that meets both of the following conditions: (a) Is beyond the limits of confinement or lost. (b) Is not wearing any tags, microchips, tattoos, or other methods of identification. WHEREAS CONTRACTOR operates an animal shelter at 102 Enterprise Drive, Elizabeth City, NC 27909 (the “Facility”); and WHEREAS, the COUNTY, through its Sheriff’s Office, operates an Animal Control Unit that has various responsibilities for dealing with animals, and the Animal Control regularly takes custody of animals for various reasons, and must provide custodial services for those animals while they are in the custody of the Sheriff’s Office, and WHEREAS CONTRACTOR can provide these custodial services at the Facility for the COUNTY. NOW THEREFORE, in consideration of mutual covenants hereinafter set forth and other good and valuable consideration, including the compensation to be paid as in hereinafter set forth, the parties hereto agree for themselves as follows: I. SERVICES TO BE PROVIDED BY CONTRACTOR AND AGREED CHARGES For service and/or materials to be furnished under this contract (hereinafter referred to collectively as “SERVICES”) and agreed charges are as follows: A. For services rendered COUNTY shall pay CONTRACTOR the total sum of \$25,000 which allocation shall be paid in six (6) monthly installments. 1	B. Cost of Dangerous Dogs, Court Case Animals and/or Large-Scale Seizures: 1. Dangerous Dogs will be held at the shelter awaiting Animal Control Board hearing. Every day past one week (beginning on Day 8) will result in a fee of \$25.00 per day per animal for the first day and \$15.00 per day per animal for every day (or part-day) thereafter. Said fees are to provide for food, shelter and vaccines. Said fees shall be paid by the COUNTY to the CONTRACTOR and shall not be contingent on the COUNTY’S collection of said fees from the pet owner. Further, said fees shall be above and beyond the allocation referenced above in paragraph 1A. 2. Court Case Animals will be held at the shelter for up to three (3) weeks. Every day past one week (beginning on Day 8) will result in a fee of \$25.00 per day per animal for the first day and \$15.00 per day per animal for every day (or part-day) thereafter. Said fees are to provide for food, shelter and vaccines. Said fees shall be paid by the COUNTY to the CONTRACTOR and shall not be contingent on the COUNTY’S collection of said fees from the pet owner. Further, said fees shall be above and beyond the allocation referenced above in paragraph 1A. 3. Large-Scale Seizures create an extreme burden on the CONTRACTOR. “Large-Scale Seizures” shall mean any group of animals brought to the CONTRACTOR’S facility at one time together in excess of eight (8) animals. Every day past one week (beginning on Day 8) will result in a fee of \$25.00 per day per animal for the first day and \$15.00 per day per animal for every day (or part-day) thereafter. In these instances, the COUNTY will notify the CONTRACTOR in advance how many animals are being seized in order to coordinate delivery of said animals in a timely and efficient manner. All health issues or possible health issues must be disclosed prior to bringing an animal to the shelter. 4. In all such cases the COUNTY will file a Bond and Forfeiture notice with the Court within seven (7) days of seizure of animal(s). C. CONTRACTOR shall operate the animal shelter, hereinafter referred to as “the Facility” pursuant to the following conditions: 1. The Facility shall operate within the guidelines and requirements of the NC Department of Agriculture as it relates to capacity of animals and limits set on the number of animals that the Facility can maintain. Current licensed capacity is 118 cats and 69 dogs although the parties recognize and acknowledge that CONTRACTOR only has 66 cat cages and 42 dog kennels. 2. The COUNTY shall direct any Owner Surrender callers to contact the CONTRACTOR for follow-up and scheduling. Any resident wanting to surrender their animal(s) must contact the SPCA for an appointment, and said animal(s) shall not be delivered to the shelter by animal control or deputies. 3. The COUNTY shall notify the CONTRACTOR of any and all Animal Control intakes that are arriving at the Facility in advance (meaning as soon as they are enroute). 4. The COUNTY will use appropriate forms, generated by the CONTRACTOR to identify the animals that are being transferred to the shelter. These forms shall be fully and accurately completed as well as signed by the Animal Control Officer. Both the Animal Control Officer and 2
a CONTRACTOR staff member must sign the forms. Said forms shall include, at a minimum, the following information: a. Record Date b. Detailed Animal Information: Species, color, breed, sex, age, weight c. Reason taken into custody d. Specific location where custody was taken (full address) e. Owner name and contact information if known f. Documentation of communication with owner, if any, or of any legally required attempt to contact owner g. Disposition in Court Case Animals h. Reports on Dangerous or Bite Dogs 5. All forms will be specific in detail regarding the animal, especially bite animals or dangerous dogs. 6. If an animal is tagged and/or chipped, the COUNTY shall make every effort to identify the owner(s) and return the animal to them. In the event the owner cannot be found, the COUNTY may transfer the animal to CONTRACTOR’S facility. 7. Under no circumstances shall the COUNTY deliver any critically ill or injured animals (as defined below) to the facility after the facility’s normal operating hours. All care, including medical care and/or euthanasia, for such animals will be the sole responsibility and expense of the COUNTY. It shall be the COUNTY’S responsibility to arrange for an “after hours” veterinarian to be on call or to transport such animals to an emergency veterinarian. 8. “Critically injured or ill” shall include but not be limited to an animal severely injured beyond the scope of minor injuries, non-responsive animals, an animal not able to ambulate on all four limbs or ill to the point of significant lethargy. II. TERM OF CONTRACT The term of this Contract is from July 1, 2025 to December 31, 2025. Either party may nonetheless cancel this Contract upon no less than thirty (30) days written notice to the other party by certified mail or personal delivery. III. CONTRACTOR’S RESPONSIBILITY TO THE PUBLIC A. The CONTRACTOR shall operate the Facility as an Animal Shelter in accordance with all applicable law, including but not limited to the NC General Statutes Chapter 19A-60 Protection of Animals, NC Dept. of Agriculture Veterinary Division, NCDHHS Controlled Substance Act and County Ordinance Chapter 91-Animals. B. The Facility will operate as an Animal Shelter as defined in NCGS: 91A-23(5), which states the definition of a animal shelter to be “Animal Shelter” meaning a facility which is used to house or contain seized, stray, homeless, quarantined, abandoned or unwanted animals and which is under contract with a county, city, town, or other municipality, or by a duly incorporated humane society, animal welfare society, society for the prevention of cruelty to 3	animals, or other nonprofit organization devoted to the welfare, protection, rehabilitation, or humane treatment of animals. C. The Facility will receive all sick and injured cats and dogs during the Facility’s normal operating hours. “Sick and injured” is defined as visible injuries such as significant visible scarring, open wounds, significant and consistent limping. The Shelter Manager shall assess the severity of the animal(s)’ condition to determine the best response for the animal(s)’ welfare and that of the shelter population and staff. If the animal(s) is/are critically injured as defined in I.C.8. above, the Shelter Manager may divert the deputy and/or animal control officer to take the animal(s) to a veterinarian at the expense of the CONTRACTOR during the facility’s normal operating hours. Small domestic mammals, domestic birds, reptiles, exotic animals, or livestock will be at the discretion of the shelter management. D. The Facility will provide isolation runs for bite dogs for their ten-day quarantine and isolation runs for dogs deemed dangerous pending their Animal Control Board hearing. Additionally, the Facility will provide two temporary intake runs for dogs which are located in the Animal Control Officer’s room of the Facility. In no case shall an Animal Control Officer ever leave a critically ill animal (as defined above in paragraph I.C.8.) in said temporary intake runs after the facility’s normal operating hours. E. The Facility will receive COUNTY animals, impound them, feed them, house them, and obtain necessary veterinary services for them following the legal transfer of custody. F. Legal transfer of custody occurs upon receipt of a signed form referenced in paragraph I.C.4. above. IV. CONTRACTOR’S RESPONSIBILITIES TO THE COUNTY AND COUNTY’S RESPONSIBILITIES TO CONTRACTOR A. CONTRACTOR shall be responsible for all utility bills, heating, telephone, internet, all supplies, and operating expenses of the animal shelter. B. CONTRACTOR shall be responsible for maintenance of the Facility to include cleaning, painting, repairs, and the cost of maintaining the facility’s reasonable normal wear and tear. C. CONTRACTOR shall be responsible for staffing the shelter seven (7) days a week. D. CONTRACTOR shall be responsible for providing food for all animals in residence at the shelter, and all supplies that are required by animals. E. CONTRACTOR shall keep records on all animals placed in CONTRACTOR’S care, adopted, euthanized, fostered, died on property, or transferred. F. COUNTY will accept euthanized animals from CONTRACTOR and dispose of them in a legally appropriate manner. 4

G. CONTRACTOR shall furnish COUNTY with a copy of its audit report performed by a certified public accountant. No later than six (6) months following the CONTRACTOR'S fiscal year end. The CONTRACTOR shall make available all of the Facility's records/reports for inspection at reasonable times upon reasonable notice by authorized representatives of the County. The records should include, but not be limited to, intake/outcome, certification status, and state inspections. H. CONTRACTOR shall be responsible for the payment of all Local, State and Federal taxes, Social Security tax, Unemployment tax, Unemployment Insurance taxes, and all required professional licensing associated with CONTRACTOR'S personnel. V. INDEPENDENT CONTRACTOR In performing these services, CONTRACTOR is acting as an independent contractor, and shall perform services in accordance with the currently approved methods and practices in the CONTRACTOR'S professional capacity, with the facility operating procedures, and in accordance with the standards, and requirements of the COUNTY, State regulations as well as the NC Department of Agriculture, the NC DHHS, and the DEA Controlled Substance Act. All decisions regarding the treatment of animals brought to the shelter shall be made in the best interests of the animal's welfare and the safety and well-being of the shelter population, the staff and volunteers. VI. INSURANCE AND INDEMNITY The CONTRACTOR shall indemnify and save harmless the COUNTY, its agents and employees from and against all actions, liability, claims, suits, damages, cost or expenses of any kind which may be brought or made against the COUNTY or which the COUNTY must pay and incur by reason of or in a manner resulting from injury, loss or damage to persons or property resulting from negligent performance of or failure to perform an of its obligations under the terms of the Contract. The COUNTY shall indemnify and save harmless the CONTRACTOR, its agents and employees from and against all actions, liability, claims, suits, damages, cost or expenses of any kind which may be brought or made against the CONTRACTOR or which the CONTRACTOR must pay and incur by reason of or in a manner resulting from injury, loss or damage to persons or property resulting from negligent performance of or failure to perform an of its obligations under the terms of the Contract. The CONTRACTOR shall be fully responsible to the COUNTY for the acts and omissions of its sub-contractors and of persons either directly or indirectly employed by it, as the CONTRACTOR is the for the acts and omission of persons directly employed by it. In addition, the CONTRACTOR shall comply with the NC Workers Compensation Act and shall provide for the payment of workers' compensation to its employees in the manner and to the extent required by such Act. In the event the CONTRACTOR is excluded from the requirements 5	of such Act and does not voluntarily carry workers compensation coverage, the CONTRACTOR shall carry or cause its employees to carry adequate medical accident insurance to cover an injury sustained by its employees or agents during the performance of SERVICES. The CONTRACTOR agrees to furnish the COUNTY proof of compliance with said Act. Or adequate medical/accident insurance coverage upon request. The CONTRACTOR, upon request by the COUNTY shall furnish a Certificate of Insurance from an insurance company, licensed to do business in the State of North Carolina. And acceptable to the COUNTY verifying the existence of any insurance coverage required by the COUNTY. The Certificate will provide for sixty (60) days advance notice in the event of termination or cancellation of coverage. VII. HEALTH AND SAFETY The CONTRACTOR shall be responsible for initiating, maintaining and supervising all safety precautions and programs in connection with the work. The CONTRACTOR shall take all necessary precautions for the safety of and shall provide the necessary protection to prevent damage, injury, or loss to all employees from the work and other persons who may be affected there. VIII. NON-DISCRIMINATION IN EMPLOYMENT The CONTRACTOR shall not discriminate against any employee or applicant for employment because of age, sex, race creed or national origin. The CONTRACTOR shall take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their age, sex race creed or national origin. In the event the CONTRACTOR is determined by the final order of an appropriate agency or court to be in violation of any non-discrimination provision of federal, state, or local law or this provision this Contract may be cancelled, terminated, or suspended in whole or in part by the COUNTY and CONTRACTOR may be declared ineligible for further COUNTY contracts. IX. GOVERNING LAW This contract shall be governed by and in accordance with the laws of the State of North Carolina. All actions relating in any way to this contract shall be brought in the General Court of Justice of the State of North Carolina or in the Federal District Court for the Eastern District of North Carolina. X. OTHER PROVISIONS This contract is subject to such additional provisions as are set forth in any addendum executed separately by each party and attached hereto. 6
